# **Terms & Conditions / Cancellation Policy**

In these Terms and Conditions, 'UNBOUNDED' means the CUSTOMER UNBOUNDED COMMV, with registered office at Holsbeeksesteenweg 143, 3010 Kessel-Lo, with CBE number 0589.977.457, operating under the trade name PRAGMATIC WEB SECURITY.

UNBOUNDED offers security advisory services and security training services (hereinafter referred to as the "Services") to its customers, hereinafter referred to as CUSTOMER. The Services are delivered to CUSTOMER, according to the present terms and conditions, to which CUSTOMER agrees and which shall prevail over any conflicting purchase terms from CUSTOMER.

# Pricing and payment conditions

All prices indicated are without VAT. In case of late or non-payment of due invoices by CUSTOMER, UNBOUNDED shall be entitled to suspend the performance of its Services to CUSTOMER for as long as the invoices are not paid. #### Cancellation
